



Memorandum of Understanding
Between

And
Viklang Sathi Trust, Lucknow

This memorandum of understanding (MOU) is made by and between Viklang Sathi Trust, having its office at Lucknow which expression shall mean and include unless repugnant to the context or meaning thereof, its successors and permitted assigns of the one part

And

Shia P.G. College located at Sitapur Road, Khadra, Lucknow hereinafter referred to as "SPGC" which expression shall mean and include unless repugnant to the context or meaning thereof, its successors and permitted assigns of the other part.

Viklang Sathi Trust and SPGC are hereafter referred to individually as "Party" and collectively as "Parties" on 16/07/2015.

1. Preamble

Whereas- Viklang Sathi Trust will help in the development of disabled persons by motivating and training them in Lucknow through its channel named Divyangam.

Whereas Shia P.G. College is a leading college offering several courses at Graduation and Post-Graduation Level. Where many disabled students are studying.

Whereas Viklang Sathi Trust as part of its development activities desires to collaborate with SPGC for promoting development of disabled persons by motivating and training them so as to help them in developing character and competence building leadership qualities and empowering youth with skills like creative writing and saving people from self-destructive habits and leading a meaning cultured life.

Whereas SPGC has shown its readiness to collaborate with Viklang Sathi Trust form promoting the Development of disabled persons by motivating and training them course and to provide all required infrastructure and facilities for running and conducting this program.

2. Role and Responsibilities

Shia P.G. College will bear responsibilities under this MOU and Viklang Sathi Trust shall undertake the following activities:

- a. Provide 30 hours of certificate training course.
- b. It will decide course content, schedule, duration, criteria for participation of disabled students. The proposed syllabus for disabled students shall be as per attachment submitted along with MOU. However, there can be modification in the course based upon the needs and concerns of both the parties.
- c. Provide faculties for entire course on development of disabled students. Following shall be the concern people for conducting this course:
 - i. Name and designation of concern people
 - Dr. Pradeep Sharma, Coordinator, Department of Journalism and Mass Communication
 - ii. Apart from these, there can also be guest faculties.
- d. Complete student feedback.
- e. Evaluate the candidates and provide certificate on successful completion of the certificate course on Disabled Students.
- f. Conduct one hour duration class once a week. Day and Timing shall be fixed after consultation between both the parties. However, there can be modification in it based upon the needs and concerns of both the parties.

Shia P.G. College's responsibilities under this MOU

SPGC shall undertake the following activities:

- a. Provide ambience for conducting certificate course in its campus. In case of online classes, it shall host and provide the online link.
- b. Promote the course and provide potential candidates for attending the course.
- c. Allow students of SPGC to attend the certificate course.
- d. Assign a teacher volunteer and few student volunteer for supporting the Course Coordinator and Moderator in conducting course.
- e. Bear the charges for any printout, notes etc. required to be distributed in the classroom to be coordinated by counselling cell with prior permission of Principal.

3. It is mutually understood and agreed by and between the parties that:

Viklang Sathi Trust and SPGC shall work together on non-exclusive basis for the successful completion. Course mentioned thereof.

4. Funding:

Viklang Sathi Trust will not charge anything from Shia P.G. College to conduct this course.

5. Limitation of Liability:

Neither party shall be liable for any special, indirect, incidental, punitive, contingent nor consequential damages or losses suffered out of or in connection with the aforesaid MOU whether as a result of a breach of this MOU or otherwise.


6. Effective date and signature


