



Memorandum of Understanding  
Between  
Shia P.G. College, Lucknow (First Party)  
And  
Aaghaz Foundation, Lucknow (Second Party)

This memorandum of understanding is made on 9<sup>th</sup> Day of **July, 2019** between Shia P.G. College, Lucknow represented by Dr. T. H. Naqvi and Dr. Agha Parvez Masih of Aaghaz Foundation, Lucknow.

**Preamble:** Sharing a common desire to empower the society by eradicating illiteracy among students of our college by providing them scholarship to prevent dropping out of college, in order to ensure that no student should be deprived of education due to their economic condition. In order to share the facilities and expertise available in each other's organisation herewith sign a Memorandum of Understanding (MOU) which read as follows:

**Infrastructure:** Shia P.G. College will provide its Infrastructure for the Programs/Lectures/Seminars/Symposiums. This will include K-Hall auditorium, Laboratory, Reading room of Khateeb-E-Akbar Library and smart class rooms. Aaghaz Foundation, Lucknow will facilitate in constructing the consensus of college students for bringing change in the society as a stakeholder.

**Research Material:** Aaghaz Foundation, Lucknow will facilitate the college students and faculty members to create and to offer a platform for providing scholarships to needy and bright students recommended by committee, sharing of research ideas, to organize debates, research

papers, articles and to sponsor other students centric activities etc. We will do every possible efforts to support academic activities in different Indian languages, the organization will Publish articles, journals, books etc. to escalate social temperament among students and to motivate and develop awareness in society especially lower economic strata.

**Curriculum Development:** The experiments and workshops related with the topics from course curriculum/ syllabus of certificate course/ Add-On courses/ Generic elective courses for skill enhancement will be conducted. All of these courses will be approved by Board of Studies, Academic Body of the Shia P.G. College. Aaghaz Foundation, Lucknow will provide study material, help in field survey, secondary data collection to facilitate the students, research scholars and faculty members for the development of curriculum and pedagogy development.

**Pedagogy:**

1. Aaghaz Foundation, Lucknow will be pleased to provide training to students, teachers, scholars and trainers, orientation and technical sessions, workshops offline/ online for the benefit of students, teachers and scholars of Students in particular and each and every stakeholder in general, Shia P.G. College, Lucknow.
2. Aaghaz Foundation, Lucknow along with the different departments of students work together in mutually agreed terms for carrying out training programs, lectures, seminars, conferences, workshops, fairs, counselling, services, and dissemination of any literature, awareness campaigns or any other research activities.
3. Aaghaz Foundation, Lucknow will collaborate in Research Work/ Projects/ Dissertations to encourage easily accessible literature, and advocate community on issues of education and literacy.

**Steering Committee:** There will be a steering Committee comprising of four members, two from Shia P.G. College, Lucknow and two from Aaghaz Foundation, Lucknow. The Committee will look after all the proposals and other related issues.

**Timeline of MOU:** The above MOU will be effective for Five years from the date of signing. The MOU will be periodically reviewed in a joint meeting to assess the progress and development of the present programs and also to identify new areas for collaboration.

The MOU reflects the commitments of respective organisations to terms and conditions mentioned in the MOU. This MOU shall be amended or terminated at any other time

by either party provided that notice of termination or amendment is provided by the notifying party to the other party within thirty (30) days of the date on which the termination or the amendment is intended to be effective. Any amendment or termination shall not have effect on any arrangement in place at the time that the notice is to be served, where the arrangement arises from any supplementary agreements resulting from this MOU. Upon termination the provisions of this MOU and corresponding program, agreements shall continue to apply to ongoing activities until each is completed.

If any T.A.-D.A. of visiting faculty is required, it will be paid from the resources available in the college from Self Financing Programs and Departmental Grant with prior approval of Principal, Shia P.G. College Lucknow. All supporting staff will be provided by both parties agree to the above in Principle subject to such other formalities required by the respective Governing bodies including the approval of competent authority.
