



Memorandum of Understanding

Between
Shia P.G. College, Lucknow
And
Shubham Soti Memorial Trust, Lucknow

Shia P.G. College located at Sitapur Road, Khadra, Lucknow, the first party (hereinafter referred to as SPGC) which expression shall mean and include unless repugnant to the context or meaning thereof, its successors and permitted assigns of the other part.

And

This memorandum of understanding (MOU) is made by and between, Shubham Soti Memorial Trust, having its office at B-6, Nirala Nagar, Lucknow which expression shall mean and include unless repugnant to the context or meaning thereof, its successors and permitted assigns of the one part.

SPGC and Shubham Soti Memorial Trust are hereafter referred to individually as "First" and "Second" Party and collectively as "Parties" on 11/07/2016.

This Memorandum of Understanding (MOU) sets out the framework for the cooperative relationship between the parties to enhance quality of course and contribution towards the same by both the parties.

Provisions:

1. Effective Date and duration of MOU:

This MOU takes effect from the date of signing by both the parties and initially will continue for a period of three years. Prior to the expiry of this MOU the parties may agree in writing to extend or curtail the period.

2. Areas of Co-Operation and Consultation:

The parties agree to collaboratively work towards effective development and delivery of road safety awareness among the students and staff members of the Shia P.G. College, Lucknow.

3. Both the Parties will collaboratively work hardly in the following areas besides other issues as arising from time to time.

(A) Role of Shubham Soti Memorial Trust

- a) Shubham Soti Memorial Trust will assist in designing road safety awareness programs.
- b) Will facilitate in organising road safety awareness programs/ workshops/ seminars/ conferences and trade fairs.
- c) Will help in bringing eminent motivators, industry leaders and sector related academia and researchers.
- d) Sourcing live projects for the students from corporations in the sector.
- e) Other related initiatives with an objective of developing awareness among the Shia P.G. College, Lucknow students and staff members.

(B) Role of Shia P.G. College, Lucknow

- a) Shia P.G. College faculty shall also assist Shubham Soti Memorial Trust in facilitating and designing training programs for its members and their staff as a continuous awareness process.
- b) Shia P.G. College will conduct Diploma and Certificate courses and whenever necessary will partner with Shubham Soti Memorial Trust.
- c) Shia P.G. College will set up an advisory board for to assist Shubham Soti Memorial Trust.

4. Use of Name and Logo:

Both the parties will use the name and logo of the other party for publicity, advertising or news release only after written permission from the party.

5. Resolution of Dispute:

This MOU outlines the framework of a working relationship between the parties. In case of dispute the matter will be resolved by committee set up by the Principal, Shia P.G. College with representatives from both parties. If the matter is not resolved any dispute will remain subject to the jurisdiction of courts at Law.

6. Finances:

This MOU will not generate any financial obligations on the two parties. Whenever necessary separate approvals will be obtained from relevant authority independent of this MOU.


7. Termination:

Either party may terminate this MOU by providing a minimum of one month written notice to the other party. The termination of this MOU will not affect any activity or project that is subject of a further agreement between the parties unless the relevant agreement provides otherwise.




